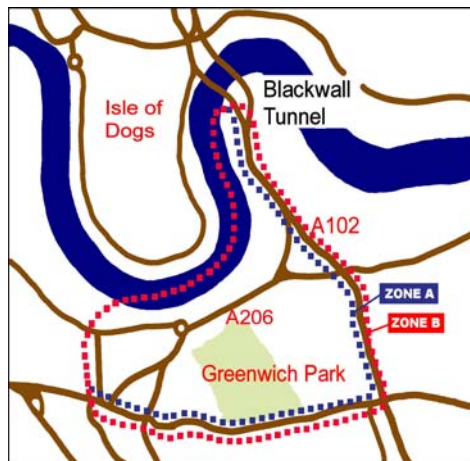

### ABD Launches Campaign Against Road Tolls in Greenwich

The Association of British Drivers (ABD) has launched a campaign against the proposed congestion charge that would cover a wide area of Greenwich, and against any tolls on the Blackwall Tunnel.



Transport for London (TfL) and Greenwich Council are conducting studies of "road traffic demand management" in the Greenwich area. This includes consideration of a congestion charge (i.e. a road toll) on the area bounded by the A102 and A2 – which includes Greenwich park and Greenwich town centre. See diagram to the left.

As you can see, the scheme might also cover the Blackwall Tunnel and one option, even if a wide area charge like the central London congestion tax is not implemented, is to impose a toll on the Blackwall Tunnel.

The joint study of the options is being supported by surveys of residents – more recently by Accent Group but there have been other polls the results of which TfL seem reluctant to disclose. The latest survey asks respondents to consider two possible zones – marked A and B on the map, the time of operation and the charges. Charges of £2, £4 or £6 are mentioned but it could be higher for larger vehicles.

The ABD is opposed to all forms of road pricing and the general public seems to agree with us – the national petition which recently collected over 1.8 million signatures against it was created by ABD member Peter Roberts. But the Government is continuing to bribe local authorities with promises of cash from the Transport Innovation Fund and Greenwich is yet another example of where this might take place. The ABD has already commenced a similar campaign against the proposal for Manchester, but we are now writing to every single resident in the London Borough of Greenwich (over 100,000 homes), to make sure that they know about this scheme and how to object to it.
